  - "Just wondering whereas Métis we fit into what's happening at this meeting. Looks to me that we are ugly cousins, we fought the same battles as our first nation families, yet we are treated like 3<sup>rd</sup> nation. Right to the end, no Métis reflections" Words of Elder Dennis Falcon
  - Minister Pruden would like to write a letter to have them come and speak to us.
  - President Shiley Isbister suggested we do a presentation of who we are, we are more than jiggers and fiddle players.
  - President Jeremy Denomie Say we should set up a call with the Chair and co-chair of IAMC, we have never received a report from the MN-S Marg Friesen representative.
